Readymade garments like Pant, Trouser, Shorts, jacket, padding Jacket, Parkas, Top, Skirt, Capri, Blouse, Dress, Jumpsuit, Pyjama set, T-shirt, Tunic, Stretch trouser, Vest, Dungarees made of woven fabric 100% cotton, cotton/spandex (optical white, dyed, yarn dyed), cotton/polyester, 100% linen, linen/cotton, linen/viscose, 100% polyester, 100% polyamide, polyester/polyamide, polyester/spandex white and dyed as well as polyester/cotton/polyamide in color navy and black, 100% viscose yarn dyed woven fabrics; Made of knitted fabrics made of 100% cotton, cotton/elastane, cotton/modal, cotton/polyester, 100% polyester dyed and cotton/polyester(undyed)/elastane in white and denim blue as well as cotton/viscose in grey melange also polyester/viscose/elastane in color blue; Made of woven denim fabric made of 100% cotton, cotton/elastane, cotton/polyester, cotton/polyester/elastane and cotton/polyester/viscose/elastane in color indigo, blue black & black (polyester part undyed) and 100% lyocell in color indigo and black; Including accessories like white woven fusible interlining made of 100 % cotton, polyester/cotton as well as nonwoven fusible white interlining made of polyester/polyamide, 100% polyester staple fibre, sewing thread & embroidery thread, woven label, printed label, plastic button, metal button, snap fastener, rivet, eyelet, hook and eye, twill tape, elastic, drawstring, drawcord, zipper and pocketing fabrics made of 100% cotton & cotton/polyester woven fabrics

The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 4, **product class I** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 4 for baby articles.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
